

#### WHO MEET IFEH

Xavier Bonnefoy the Regional Adviser on Environmental Health Planning/ Ecology of the World Health Organisation, Regional Office Europe, together with several representatives from Eastern Europe and France, met Kia Regner and several members of the IFEH Council at a meeting in Aberdeen on Friday, 24th and Saturday, 25th May 1996. Mr. Bonnefoy stressed the importance of developing National Environmental Health Action Plans, identifying problems and setting priorities to solve problems, he said the Environmental Health Profession will be strengthened by training and sharing information and it was important that countries with a strong tradition in Environmental Health should share their experience and success with countries with little experience and lacking national environmental health organisations.

The close links developing between the WHO and the IFEH were emphasised by Mr. Bonnefoy suggesting his support for the IFEH:

- (a) to use the WHO worldwide web:
- (b) to become a collaborating centre for the WHO;
- (c) by providing administrative assistance for six months free of charge

#### IFEH COUNCIL MEETING

25th/26th May at the Aberdeen Conference Centre, Scotland, UK. It was agreed that policy documents and budget reports should be circulated to all members six weeks prior to Council meetings.

The Association of Public Health Officers, Kenya, was accepted as a full member.

The following applications to become Academic Associate Members were successful:

Hong Kong College of Technology British Columbia Institute of Technology West Lothian College, Scotland.

The result of the ballot supported the change of title from Associate Body to Associate Member or Academic Associate Member.

# MEMORANDUM AND ARTICLES OF ASSOCIATION

It was agreed that these urgently require updating and all members are invited to send proposals to Michael Halls ("Eastfield" Abbotsford Road, Galashiels TD1 3DS Scotland Fax 01896 758089) as quickly as possible.

It was agreed that the proposed endorsement of food hygiene certificates should be progressed by a meeting of Bryn Jones (Secretary of IFEH), John Frater (Chief Executive of the Royal Environmental Health Institute of Scotland), and Dee Waite (Chartered Institute of Environmental Health), at the earliest opportunity.

It was agreed that the Finance Working Group should consider the proposal that a grant and/or loan of up to £1,000 should be made available to subsidise attendance at future World Health Congresses of member organisations who would otherwise not be able to attend and to act as seed money for future congresses. A decision will be made at the next Council meeting in November.

The Public Relations Officer requested all members to consider sponsorship of the IFEH Annual Report by the placing of advertisements in the Report. Anyone interested should contact the Public Relations Officer as soon as possible.

The accounts submitted by the Treasurer were approved.

It was agreed that Kia Regner, the current Chair of the Council, should continue in office until 1st January 1997 so that the President and the Chairman would take up office in alternate years.

One member urged organisers of future World Health Congresses to reduce the registration fees to enable more representation from abroad.

The Secretary was asked to ascertain the types of software accessible to the majority of members so that cheaper and more effective forms of communications could be considered.

It was agreed that the Chair should decide on the venue for the next Council meeting, which may be South Africa.


